"DANUBE - RIVER OF COOPERATION"

About the main organizer:

International scientific conferences "Danube – River of Cooperation" are held every year starting from 1989, based on the project of Dr. Edita Stojić, Research Professor at the Institute of International Politics and Economy.

The first five successful conferences highlighted the great interest of not only scientific workers, but also of the wider professional public for a very wide range of topics related to the Danube and its tributaries. The need for establishing associations of citizens interested in international cooperation and for development projects in the sustainable use of natural and cultural and historical resources in the macro-region of the Danube basin was pointed out.

Final Document of the 30th International Scientific Conference "Danube - River of Cooperation"

Thus, in April 1994, the *International Scientific Forum "Danube - River of Cooperation" (ISF "DRC")* was established. Conferences "Danube - River of Cooperation" were scheduled for each autumn. The only exception was in 1999, when there were no conditions for organizing a traditional annual conference due to the NATO bombing of the FRY. However, that is why the first round-table-conference of the *ISF"DRC"* was held in the beginning of the next year when the effects of the bombardment on life in the Serbian Danube Region and the Danube River itself were considered and discussed. The **Public Enterprise "Belgrade Fortress"** manages the historical heritage site situated at the ridge over the confluence of the Sava and the Danube, a site in use for over two millenniums. Six centuries elapsed since Belgrade became the capital for the first time in its history. The core of today's two million agglomeration is the Belgrade fortress and the Kalemegdan Park. The

Fortress and the Park form a unique spatial entity with clearly visible remains of the Fortress divided into Upper and Lower Town, with two distinct styles – elements of medieval architecture combined with dominant baroque solutions typical for the 18th century. THE FLOW OF THE CONFERENCE WORK

THE FIRST DAY OF THE CONFERENCE - September 23

The work of the Conference began in the *Collegium Hungaricum* at 10:00 a.m. with greeting speeches of organizers. Director Mrs. Klara SZENTGYÖRGYI spoke about the goals and activities of the host-institution and Mrs. Edita STOJIĆ KARANOVIĆ, founder-president of the *ISF"DRC"* presented shortly the mission and the results achieved in the last three decades of the activities.

The first working session on the first conference-day started with the presentation of Academic Prof. Dr. Imre GARACZI from Hungary, who spoke about the mental background of geopolitics and geostrategy in modern East-Central Europe. Then two outstanding experts in the inland waterway thematic, spoke about this themes: Prof Dr. Bernd KORTSCHAK, Professor of the Vienna University of Economics and Business presented his research-work about thirty years of change on the Middle and Lower Danube regarding inland navigation. After him, Prof. Dr. Zoran RADMILOVIĆ, member of the Engineering Academy of Serbia presented his research-work on navigation through the locks on the Danube and the reconstruction of the locks 1 and 2 at Đerdap (Iron Gate).

At the second working session of the first conference-day four research-results were presented:

The co-authored work of Prof. Dr. Snežana ŠTETIĆ, from Belgrade University and Novi Sad University, and MSc. Igor TRIŠIĆ, from University of Kragujevac, Faculty of Hotel Management and Tourism covered the thematic of sustainable tourism development of rural destinations in the Danube region of Serbia. Then the tourism theme was continued by Monika WÜRTENBERGER, Tourism Expert form Germany, under the title Overtourism. The co-authored research-work of

Cornel POPOVICI STURZA, President of "Néra Ecological Group" from Romania and Milan BELOBABIĆ, President and Tourist Guide at the "AURORA Association" from Serbia under the title "10 Days in the wonderful world of South Banat" proved not only the touristic value of the treated sub-region, but the value of cross-border international co-authorship.

At the end of the morning programs on September 23rd Dr. Marina PAVLOVIĆ, from the Cultural Monument Protection Institute of Belgrade City presented the heritage values of the Belgrade Fortress and their preservation. Her presentation served well as an introduction to the afternoon program of the conference.

The afternoon-program of the first conference-day started at 15:00 with the sightseeing of the Belgrade Fortress, the Kalemegdan's most significant cultural and historical sights with expert guide Mr. Željko PETROVIĆ, geographer and licensed tourist guide, who explained all historical and cultural values of visited sights on the ground and under the ground of the Belgrade fortress. The participants of the 30th "DRC" rated his work as excellent. The

coordinator of this program for our conference was Mr. Relja SERATLIĆ, archaeologist and Head of Complex Revitalization Division of the Public Enterprise "Belgrade Fortress". The first day of the Conference ended at the famous and oldest Belgrade restaurant "The Question Mark" at 19:00.



THE SECOND DAY OF THE CONFERENCE - September 24th

The second conference-day was held in the Institute of International Politics and Economics. The work started at 10:00 am with the opening session moderated by Dr. Edita STOJIĆ KARANOVIĆ who talked about how the project "Danube - River of Cooperation" started 30 years ago in this Institute and resulted in the first conference with same title in Belgrade, Novi Sad and Đerdap (Iron Gate), September 28th - October 2nd 1989. The participants of that conference pointed out in the the final document "that the intensification of the Danubian cooperation covering different areas would promote closer links among the Europeans on national and regional levels." As well as that the "Danube might become a reliable tie yielding to obvious advantages, economic benefits and to the strengthening of common human values in international relations." Upon the conclusion stated in the Declaration of this first conference that scientists may contribute to the realization of above mentioned "in an interdisciplinary step to integrate ecological factors too. Within this new framework of decision-making cultural relations and tourism could emerge as integrating network along the Danube basin countries" - the work of the International Scientific Forum "Danube - River of Cooperation" had continued its activities during the 30 years following the first Conference.

The director of the IIPE, Prof. Branislav ĐORĐEVIĆ in his greeting speech said he "especially welcomes our dear guests from abroad, as well as Dr. Edita Stojić Karanović, former Director of the Institute and President and founder of the International Scientific Forum "Danube - Cooperation River", without whose tremendous effort and enthusiasm there would not have been this gathering." Thanking for his words, Dr. Stojić Karanović gave to Prof. Đorđević as a gift a book from the book-collection of the *ISF"DRC"*.

Prof. Dr. Bernd KORTSCHAK, professor of the Vienna University of Economics and Business in his speech remembered the first conferences "Danube – River of Cooperation" in which he was participating and praised the value of the project and the persistence of its' author for continuation and further developing of activities on gathering experts and scientific researchers of various fields for sharing knowledge among each others and with the wider public. He also presented a Sachertorte from Vienna, a birthday-cake for 30 years of the International Scientific Conference "Danube – River of Cooperation".

Thanking for his words and for the presented birthday-cake, Dr. Stojić Karanović give to Prof. Dr. KORTSCHAK as present the compendiums of the first conferences of "Danube – River of Cooperation", which contain also the papers of Prof. Dr. Bernd KORTSCHAK.

Goran PUZOVIĆ, Director of the Public Water-management Enterprise "SRBIJAVODE" was the next speaker. He spoke about the importance of water resource in Serbia, about problems in this field and plans for solving them. He expressed his respect and appreciation of the efforts and results of the project "Danube – River of Cooperation" in raising awareness and disseminating knowledge about the importance of sustainable use of water resources. After his speech the doyen of the *ISF"DRC"*, Mihailo SRETENOVIĆ, BSc. Eng. presented Mr. PUZOVIĆ with two compendium-books recently published by *ISF"DRC"*.





The first working session on the second conference-day, titled "The

Political and Economic Aspects of the Danube Region" began at 11:00 when Prof. Dr. Dragoljub TODIĆ, from the *Institute of International Politics and Economics*, as moderator, gave the word first to Vojislav DEĐANSKI, MSc, Faculty of Geography, Belgrade University, who presented his co-authored work with Dušan ILIĆ, MSc, Institute for European Studies, Belgrade, on the geopolitical significance of the Danube for Serbia in the 20th century. The authors based their research on the fact that "since the earliest beginnings of human history, the Danube has been a significant factor in the interconnection of nations and civilizations that lived in its basin at that time, as well as in connection with other parts of the world."

This was followed by the presentation of the co-authored work of Marina RADOVANOVIĆ and Goran SANDIĆ, students of Master Academic International Studies at the Faculty of Political Sciences, University of Belgrade, about the accession to the EU perspectives for the development of political and economic relations in the Danube basin. Upon analyzing the previous experiences of countries that have become Member States of the EU earlier, the authors came to the conclusion that also "other Danube family members can take advantage of the membership perspective in overcoming current issues and disputes" and therefore it is needed to "continue with the completion of the entire Danube puzzle in the common picture of the European Union."

The next presented work was the co-authored research-results of Svetlana RISTIĆ, architect and Dragica JOVANOVIĆ, art historian, both from Belgrade, on connecting public policies to promote regional cooperation in the Danube basin. The presentation pointed out that one of the most important public policy-issue is transport development, which has recently achieved significant results in terms of kilometers of roads built and other infrastructure network development. However, stronger relation is needed with policies in the field of tourism and cultural heritage, such as in the example of the existing railway stations on the relation Belgrade - Subotica, that are very often of cultural heritage value. Spatial plans can be used as instruments of connecting sectoral strategies and realizing their synergistic impact on the development and improvement of regional cooperation.

Zoran GAVRILOVIĆ, BSc. Eng. presented the results of his long-year researches under the title "How to Preserve the Balance and Sustainability of Natural Resources". The author pointed out that the usual divisions of resources are to "renewable" and "non-renewable", but "this is simplified division that entered into the consciousness of people understanding that 'non-renewable' resources can simply be consumed but that "renewable" last forever." He showed on examples how this attitude is wrong and that "renewable resources are vulnerable and this is a phenomenon which directly affects the sustainability."

Prof. Dr. Pero PETROVIĆ, from *IIPE*, Belgrade, presented his co-authored work with Dr. Danica PETROVIĆ, Docent at the *Synergy University*, Bijeljina, Bosnia-Herzegovina, titled "Similarities and Differences of Historic Cities as Tourist Destinations of the Danube Region". The authors started with statement that for example in the Danube region of Serbia "every single historical city is *par excellence* a tourism destination", especially Petrovaradin, Belgrade, Smederevo, Golubac, Kladovo, with their fortresses. But, "as a tourist destination, every historical city does not carry the same meaning to all tourists. The aim and purpose of tourism oriented development of a historical city must be different from tourism development of other tourism destinations" - argued the authors.

Ivana JANKOVIĆ, from the Faculty of Political Sciences, University of Belgrade presented her research-results in which she under the title "Danube as the Stone of Stumbling Block" considers the issue of the dispute between the Republic of Serbia and the Republic of Croatia regarding the border on the

Danube, which makes it difficult to establish stable bilateral relations between the two countries and therefore also the accession of Serbia to the EU.

A similar research-work was presented by Marko MILISAVLJEVIĆ, *Faculty of Political Sciences, University of Belgrade* under the title "Border dispute between Serbia and Croatia on the Danube and EU integration". The author gave an excellent overview of legal considerations of the problem and possibilities for its resolution, but showing how complicated the process could be. At the end of his presentation, he made recommendations for the Serbian side, that certainly deserve to be taken into consideration by the Serbian authorities involved in the process of solving this border dispute on the Danube.

The second working session on the second conference-day, titled "Environmental, Legal, Sanitary and Technological Aspects of the Danube Region" began at 13:00. It was moderated by Dr. Sanja JELISAVAC TROŠIĆ, Scientific Researcher of the *IIPE*. She gave the word first to Prof. Dr. Dragoljub TODIĆ, from *IIPE*, who presented his research-work under the title "International legal protection of the Danube river and contemporary international environmental law". He underlined that the topic of waste management has become one of the key issues considered as legally not properly regulated. "The attempt to draft a separate international treaty in the field of waste management (which would refer to inland navigation of the Danube) has raised some other issues of a regional and sub-regional character" – he said.

The co-authored work of Ivana KUNC, BSc. Eng., Prof. Dr. Katarina VUKADINOVIĆ, Prof. Dr. Nataša BOJKOVIĆ, from Faculty of Transport and Traffic Engineering at University of Belgrade, under the title "The Danube Commission member states' consultation process in the field of ship waste management on the Danube - political and practical aspect", presented by Ivana Kunc pointed out, that the consultation process in the field of ship waste management on the Danube among the member-countries of the Danube Commission was intensive and hard, but the process of negotiations in technical and practical aspects has to be continued, as the ongoing discussion concerning most important issue – the model of financing for oily and greasy ship waste along the Danube is not finished, yet.

The third working session on the second conference-day was devoted to final debate and adoption of the proposal for the conference final document. It was moderated by Dr. Edita STOJIĆ KARANOVIĆ, Research Professor, President of the ISF"DRC". She stated that the scientific researchworks that were presented at the first and second conference-days contain important information and messages and the next two days of the Conference will have optional programs for those participants who are interested in taking part also in these programs. Then she shortly proposed the main conclusions for the Final Document and as there was no objections, they are formulated as below, after the short data about the third and fourth day of the 30th Conference.

The second conference-day was closed at 15:00 after a luncheon-cocktail given by the International Scientific Forum "Danube – River of Cooperation".



THE THIRD DAY OF THE CONFERENCE - September 25th

The optional program for conference-participants on the third day was sightseeing of city-center and visiting museums individually or in group. Museums visited were the National Museum located in the center of Belgrade, and the Nikola Tesla Museum dedicated to honoring and displaying the life and work of the world-famous Serbian inventor.



THE FOURTH DAY OF THE CONFERENCE - September 26th

This day had an optional program for those participants of our conference, who were interested especially in inland-waterway and river-sea combined navigation issues. They participated as observers at the Constantza Port's Belgrade Day.



CONCLUSIONS AND DECLARATION OF THE 30th INTERNATIONAL SCIENTIFIC CONFERENCE "DANUBE - RIVER OF COOPERATION"

The ISF"DRC" - dedicated to improving international cooperation in the field of sustainable development and sustainable use of natural and cultural and historical resources in the Danube Basin - as always, in future will too, communicate to the government authorities and organizations at all levels the results of its activities, pointing out the problems that need to be addressed in the sustainable use of natural and cultural and historical resources in the Danube basin. At the same time *ISF"DRC"* will strengthen its existing cooperation with non-governmental organizations of the countries in the Danube Region and will continue to initiate new forms of cooperation. *ISF"DRC"*

will continue to cooperate also with civil society organizations in other regions, too, like the Visegrad 4, the Adriatic-Ionian and the Black Sea regions.

We are aware of the fact that exchange of knowledge and experience empowers the scientific and the broader public community. The constant exchange of knowledge and a strong connection among researchers is a must for every association and it is certainly for ours. But the stronger cooperation of educational programs would be important too, and it is still not sufficient.

ISF"DRC" will therefore continue to pay special attention to interdisciplinary programs and projects, promoting research results and project proposals through publishing activities and new forms of education programs, expanding and sharing knowledge in the field of sustainable use and protection of natural resources and cultural and historical heritage.

Regarding this jubilee 30th International Scientific Conference, we have to state, that, as the list of participants (attached to this Report), shows the Conference had a total of 63 participants, out of which 52 from Serbia and 11 foreign participants from 6 countries (Austria -1, Bosnia-Herzegovina -3, Germany -1, Hungary -3, Montenegro -1, Romania -2) thus qualifying this Conference as an international scientific meeting.

Some works, planned to be presented during the first and second days of the Conference, were not presented personally by their authors, who due to illness or other unexpected reasons could not personally attend. These authors are on First Conference-day: Prof. Dr. Gyöngyi MAJOR, from Hungary, Prof. Dr. Kristijan RISTIĆ, from Belgrade University (Serbia). Not personally present on the Second Conference-day were Duško DIMITRIJEVIĆ, Research professor from IIPE, the co-authors Emina AHMETOVIĆ, MSc, and Emina MEŠINOVIĆ, BSc. Eng. of agriculture, from Association for the Development and Promotion of Eco-Agriculture, Tourism and Environmental Protection (Ekopot), University of Tuzla, Faculty of Technology, Department of Agronomy (Bosnia-Herzegovina); Dr. Milorad STAMENKOVIĆ, from Inventis Clinical Trial Management, Prof. Dr. Jovan BOJKOVSKI, University of Belgrade, Faculty of Veterinary Medicine, the co-authors Jelena BANOVIĆ and Dejana PAVLOVIĆ, from Institute of Economic Sciences, Belgrade. Their abstracts were published in the Book of Abstracts and their paper will be published in the Compendium of works of the 30th International Scientific Conference "Danube - River of Cooperation" if they will send it by the end of October 2019. This is the deadline for sending the full papers valid for all the participants of the 30th Conference "Danube - River of Cooperation".

Concerning its' publishing activities, the *ISF"DRC"* will publish thematic collections of works that were presented over the last 30 years at the "Danube - River Cooperation" conferences.
